

## FILM LIBRARY TECHNICAL SERVICES FEES

---

### 1. Documentary research

- Documentary research service rates: 20 euros/hour (minimum charge – 20 euros)

50% discount for non-profit organisations and public institutions.

Full exemption for accredited researchers and teaching staff for academic research purposes.

### 2. Reproduction

#### 2.1. Graphic resource reproduction

Lo-res (72 dpi):	10 euros initial block up to 10 images 0.30 euros/additional page or unit.
Hi-res (300 dpi):	10 euros initial block up to 10 images 0.50 euros/additional page or unit.

Full exemption for depositors and/or owners of the exploitation rights with regard to their materials.

#### 2.2. Bibliographic resource reproductions

##### 2.2.1 Self-service

Self-service B&W photocopies or prints:	0.10 euros/page or unit
Self-service colour photocopies or prints:	0.30 euros/page or unit
Digitising and copy to USB pen drive or forwarding by email (self-service):	0.10/page or unit

##### 2.2.2 Scanning

Hi-res (200 dpi):	5 euros initial block up to 10 images 0.10 euros/additional image

Full exemption for depositors and/or owners of the exploitation rights with regard to their materials.

## 3. Usage licence for reproduced material

(Not including exploitation rights assignment)

### Graphic resources:

Advertising use:	60 euros/page or unit.
Other uses:	20 euros/page or unit.

50% discount on the above usage licence fees for non-profit organisations and public institutions.

Full exemption in the following circumstances:

- Accredited researchers and teaching staff for accredited academic research purposes.
- Depositors and/or holders of exploitation rights, with regard to their material.
- Activities or projects pertaining to the Ministry of Culture and affiliated entities.
- When used in documentary productions that have received an ICEC grant by private companies or undertakings that assign to Filmoteca de Catalunya the cultural-related exploitation rights over the new production. This waiver requires a contract or agreement to be in place.

The Filmoteca de Catalunya Directorate may establish full or partial exemption for materials used by private companies or entities in productions that assign cultural exploitation rights for the new production to the Filmoteca de Catalunya, by means of a collaboration agreement. The discounted sum will be established in the agreement or contract.

## 4. Loan

### 4.1. Graphic resources

First thirty **calendar days, 5% of the value** of each item, provided that this amount is not less than 60 euros. From day 31 onwards, in blocks of 30 calendar days, 10% of the value of each item.

50% discount for non-profit organizations and public institutions.

Full exemption in the following circumstances:

- Depositors and/or owners of the exploitation rights with regard to their material.

- FIAF and ACE institution members, by virtue of international reciprocity agreements.
- Activities or projects pertaining to the Ministry of Culture and affiliated entities.
- Productions by public or private entities in which the Filmoteca de Catalunya has a collaborative interest (requires an agreement or contract to be in place).

## 4.2. Bibliographic resources

Inter-library loans requested by a library:

Within Spain:	10 euros/item, plus handling costs.
Outside Spain:	20 euros/item, plus handling costs.

Inter-library loans requested by the Film Library from other libraries: amount invoiced by the loaning library, plus €1 shipping cost.

Full exemption in the following circumstances:

- Depositors and/or owners of the exploitation rights with regard to their material.
- Institutions belonging to BEG (Government of Catalonia specialist libraries) and other libraries with reciprocity agreements in place with the Filmoteca de Catalunya.
- FIAF and ACE institution members, by virtue of international reciprocity agreements.
- Activities or projects pertaining to the Ministry of Culture and affiliated entities.
- Productions by public or private entities in which the Filmoteca de Catalunya has a collaborative interest (requires an agreement or contract to be in place).

*The fees specified in sections 1, 2, 3 and 4 do not include any taxes that may be applicable.*

*The RESEARCH service is exempt from VAT in accordance with article 20 paragraph 14 letter a) of Law 37/1992 of 28 December on Value Added Tax.*
